### ORDER

As per the Government order read as 1<sup>st</sup> paper above, sanction was accorded (i) to prepare GIS based Integrated Plans in 100 selected Gram Panchayats on a pilot basis by engaging Kerala State Land Use Board at a cost of Rs. 25,88,058/-, (ii) to develop an android based mobile app by a competent Start Up Company registered in Kerala Start Up Mission, to collect field level data at a cost not exceeding Rs.6 lakhs and (iii) to conduct field level data collection through trained personnel at a cost of Rs. 7.5 per household in plain areas and Rs.10 per household in hilly areas. Accordingly, the project was piloted in 100 Grama Panchayats of the State.

2. As per the Government order read as 2<sup>nd</sup> paper above, sanction was accorded for preparing GIS based plan of 508 more Grama Panchayats in the second phase of 'Geographic Information System (GIS) based integrated planning at Grama Panchayath level for all permissible works under MGNREGA', by engaging Kerala State Land Use Board (KSLUB) at a total cost of Rs.79,44,200/-. The work is in progress and is expected to complete before 31<sup>st</sup> August 2021.



3. The Ministry of Rural Development, in the Virtual Meeting of 2<sup>nd</sup> Performance Review Committee held on 03.02.2021 directed to prepare and upload GIS plans of more Grama Panchayats and thereby fixed a target of eight grama panchayats per block. The Kerala Land Use Board, who were entrusted for providing technical support for the first two phases submitted a proposal to prepare GIS based plans in the remaining 333 Grama Panchayats of the State at a cost of Rs.52,51,114/- as detailed below to the Mission Director, MGNREGS (Kerala):

As per the letter read as 3<sup>rd</sup> paper above, the Mission Director has recommended the proposal of Kerala Land Use Board and hence requested to accord sanction for preparation of GIS based integrated plans of the remaining 333 Gram Panchayats using the services of Kerala Land Use Board at a cost of Rs.52,51,114/-and also allow to meet the entire expenditure from the available administrative expenses of MGNREGS. It was informed that the android based mobile app developed for the first two phase shall be used for the third phase as well.

5. Government have examined the matter in detail. In view of the circumstances elucidated above, Government are pleased to accord sanction to the Mission Director, MGNREGS for preparing GIS based plan of the remaining 333 Grama Panchayats of the State in the third and last phase of 'Geographic Information System (GIS) based integrated planning at Grama Panchayath level for all permissible works under MGNREGA', by engaging Kerala State Land Use Board (KSLUB) at a total cost of Rs.52,51,114/-, by meeting the entire expenditure from the administrative expenses of Mahatma Gandhi NREGS. The final bill shall be cleared as per the actual expenditure incurred towards manpower and other items; not exceeding the proposed limits.

6. The GIS Master Plan should be utilized for project planning, implementation and monitoring.
