**ORDER**

Pradhan Mantri Grama Sadak Yojana (PMGSY) is an ongoing Centrally Sponsored Scheme and Government of Kerala provide an Additional State Share as an additional State support to the Scheme. An amount of ₹20 crore is earmarked for this purpose in the Annual Budget 2021-22 under the H/A 4515-00-800-98.
