ORDER

Government had issue orders to release ₹35 lakh towards the Administrative expenses (Central share) for Pinarayi-Vengad Cluster in Phase III of Rurban Mission and ₹2.88 Crore towards the Administrative expenses (State share) for Phase I, Phase II, Phase III Rurban clusters, from previous year budget provision to the Commissioner for Rural Development (CRD), as per the GOs read as 2nd and 3rd papers above respectively.

2) While the CRD submitting the bill to District Treasury, Thiruvananthapuram for releasing the above amounts, treasury had reportedly objected the bill for want of Government Order pertaining to release of funds from current years Budget provision. Hence the Commissioner for Rural Development has requested, vide letter read as 4th paper above to revise/re-validate the Government Orders to effect the release of the fund from current years Budget provision.

3) Government have examined the matter in detail and are pleased to re-validate the Government Orders read as 2nd and 3rd paper above and to accord sanction for the release of a total amount of ₹3,23,00,000/- (Rupees Three Crore and Twenty Three Lakh only) as Administrative fund (Central

and State share) for the implementation of Syama Prasad Mukherji Rurban Mission (SPMRM) in Kerala as detailed below, from the current years Budget provision.


