ORDER

As per letter read as 1st paper above the Ministry of Rural Development (MoRD), GoI have accorded clearance to the proposal submitted by Kerala under Batch-I of 2021-22, PMGSY-III, as detailed below:

2. As per, PMGSY-III Guidelines, the design life of a PMGSY road is 10 years. Out of this, first 5 years Defect Liability Period (DLP) has to be maintained by the Contractor himself. An amount of 9% of the total construction cost has to be earmarked for this 5 year DLP. In addition to this

an one time surface renewal of the road has to be made as per the requirement in the post 5 year DLP. The maintenance cost in the DLP and post 5 year DLP (Renewal cost) has to be born by the State under State support head in each financial year budget. In the above circumstances, the Member Secretary, KSRRDA has requested, vide letter read as 2nd paper above, to accord Administrative Sanction for the above 120 road works of Batch-I of 2021-22, PMGSY-III.

3.Government have examined the matter in detail and are pleased to accord Administrative Sanction for the implementation of projects under **Batch-I of 2021-22, PMGSY-III**, as detailed below:
