## **ORDER**

As per the Government order read as 1 st paper above, an independent Social Audit Society was set up in the State under the name ,Mahathma Gandhi NREGA Social Audit Society-Kerala, registered under Travancore Cochin Charitable Societies Act 1955. Dr. Abey George, Associate Professor, KILA, Trichur was appointed as the first Director of the Society as per the order referred as 2<sup>nd</sup> paper above.

As per the Government order read as 3 <sup>rd</sup> paper above, Dr.Abey George was repatriated to his parent organisation as per the request of Director(KILA) and Sri.E.Sreekumar, Social Development Specialist has been delegated the powers of Director. Ensuing this, Government reconstituted the Selection Committee for selecting a suitable person to be appointed as Director of the MGNREGA Social Audit Society Kerala according to the relevant provisions of the Annual Master Circular 2020-21 of MGNREGS and the approved bylaw of the Social Audit Society. The Committee is headed by Dr.Asha Thomas IAS, Additional Chief Secretary(P&ARD) as the nominee of the Chief Secretary.

In the meanwhile the qualification and terms of service of the Director(MGNREGA Social Audit Society) was revised as per the Government order read as 5<sup>th</sup> paper above in line with latest guidelines of Government of India. The preliminary meeting of the selection committee held on 27.01.2021 authorised Mission Director(MGNREGS) to invite applications to the post. The selection committee interviewed the qualified candidates short listed on 06.10.21 via online and prepared a select list. As per the select list, Dr.N.Ramakanthan, Manidweepam, Villa No.#3, Nandikulangara, Mannon P.O., North Paravur has been placed in the 1<sup>st</sup> position.

In these circumstances, Government are pleased to appoint Dr.N.Ramakanthan, Manidweepam, Villa No.#3, Nandikulangara, Mannon P.O., North Paravur as the Director of Mahathma Gandhi NREGA Social Audit Society-Kerala for a period of 3 years. Sri.E.Sreekumar, Social Development Specialist, MGNREGA Social Audit Society, Kerala who is presently holding the post shall hand over his charge as Director to Dr.N.Remakanthan on proper acknowledgment.
