ORDER

As per Section 27 of the Mahatma Gandhi National Rural Employment Guarantee Act, 2005, Government of India have issued detailed instructions to the State Governments to establish the Office of the Ombudsman for of complaints relating to Grievances and disposal redressal implementation of the MGNREGS. As per the Government order read as 1st paper above, Government re-constituted the Selection Committee for preparing and recommending to Government, the ranked panel of persons found suitable for appointment as Ombudspersons for Mahatma Gandhi NREGS in accordance with the instructions issued by Government of India. The Selection Committee identified only ten persons as eligible for appointment from the 38 applicants who attended the interview and the ranked list of these persons were finally notified as per the Government order read as 2nd paper above after scrutiny of objections received from the public with the affirmation that the appointment from the rank list will be subject to the final outcome of the W.A.No.2151/2019 filed before the Hon'ble High Court of Kerala against cancellation of the previous draft rank list notified. As per the reference 3rd paper above, the Hon'ble High Court has dismissed

the writ appeals.

2. In these circumstances, Government of Kerala in exercising the powers conferred under Section 27 of MGNREG Act 2005 and in accordance with the instructions issued by Government of India are pleased to appoint the following persons as Ombudspersons in the 10 districts of the State noted against their names, under MGNREGS, for redressal of grievances and disposal of complaints relating to implementation of MGNREG Act and the Schemes made under the said Act by the State, from the ranked panel notified as per Government order read as 2nd paper above. The Ombudspersons appointed in the districts of Eranakulam, Thrissur, Malappuram and Kozhikkode will hold full additional charge of Ombudspersons in the districts of Kasargod, Palakkad, Wayanad and Kannur respectively, until further orders.
