### **ORDER**

As part of development of Kadamakkudy Panchayat in Vypin Constituency, Goshree Islands Development Authority (GIDA) has initiated several projects using their own fund. One of these projects is the Construction of a Bridge connecting Kothad and Chennur islands of Kadamakkudy Panchayat. Administrative Sanction was accorded for an amount of Rs. 37.50 crore for this project, vide Government Order read as 1st above. But the project was not implemented yet due to disputes regarding the alignment.

- 2) The Secretary, Goshree Islands Development Authority has reported that the revised alignment through the existing road has been approved by the decision of the 31<sup>st</sup> General Council of Goshree Islands Development Authority and the revised estimate of an amount of Rs. 35,97,00,000/-(Including 12.5% centage charge & GST) prepared by Public Works Department in PRICE software has been forwarded to Government for Administrative and Expenditure Sanction vide letter read as 2<sup>nd</sup> above.
- 3) Government have examined the matter in detail and are pleased to accord Administrative Sanction amounting to Rs. 35,97,00,000/-(Rupees Thirty Five Crore and Ninety Seven Lakh only) for the construction of Kothad -Chennur Bridge in Vypin Constituency using the own fund of Goshree Islands Development Authority. The Secretary, Goshree Islands Development Authority shall submit a copy of TS estimate to Government accordingly.
