ORDER

As per the advise of Kerala Public Service Commission Shri.Navas.A was appointed as Municipal Secretary Grade-III at Piravom Municipality vide the Government Order read as 1st paper above. The officer joined duty at Piravom Municipality on 17/03/2017 FN.

The Director of Urban Affairs vide the letter read as 3rd paper above has reported that no disciplinary proceedings /vigilance case is pending against the incumbent during the period of probation and the work and conduct of the incumbent is good. It is also reported that the normal period of declaration of probation in the cadre of Municipal Secretary Grade III is two years of duty within a continuous period of three years. But the incumbent has passed the prescribed municipal test only on 18/10/2020 . Hence the Director has recommended to extend the period of probation of the incumbent up to 18/10/2020 AN and declare the same with effect from 19/10/2020 FN. The Accountant General has reported that the incumbent has not availed any leave other than casual leave during the period of

probation.

Government have examined the matter in detail and are pleased to extend the period of probation in respect of Shri.Navas.A, Municipal Secretary Gr.III up to 18/10/2020 as per Rule 21 of General Rules of KS&SSRs, and are also pleased to order that, Shri.Navas.A, Municipal Secretary Grade.III has satisfactorily completed the prescribed period of probation in the cadre of Municipal Secretary Grade-III with effect from 19/10/2020 FN as per Rule 20 (b) of General Rules of KS&SSRs.


