ORDER

The paucity of land is one of the major hurdles faced in waste management and even though DPRS are being prepared for local bodies through Kerala Water Authority, in many cases there is no land identified and hence the projects cannot take off. More over providing sewer networks in all cases may not be viable. Decentralized sewage treatment plants / septage treatment plants may be viable in such cases for which land availability may be assessed. For establishing a septage treatment plant, land about 2-2.5 acres is needed .

Vide the meetings read above, it was decided to constitute a four member working committee consisting of Land Revenue Commissioner, Principal Director LSGD, Managing Director Kerala Water Authority, and Executive Director Suchitwa Mission for identifying the land for the purpose of setting up of decentralized Sewage & Septage Treatment plants for the entire State.

In this circumstance, Government are pleased to constitute a four member working committee consisting of Land Revenue Commissioner, Principal Director LSGD, Managing Director - Kerala Water Authority,

and Executive Director Suchitwa Mission for identifying the land for the purpose of setting up of decentralized Sewage & Septage Treatment plants for the entire State. The convenor of the committee will be Executive Director, Suchitwa Mission.
