ORDER

As per G.O read 1st above Smt.Vrija N.K was appointed as Municipal Secretary Grade-III as per the advise of Kerala Public Service Commission . The officer joined duty on 16/03/2017 FN.

The Director of Urban Affairs, as per the letter read as 3rd paper above has reported that no disciplinary proceedings/vigilance case is pending against the incumbent during the period of probation and the work and conduct of the incumbent is good.The period of declaration of probation in the cadre of Municipal Secretary Grade III is two years of duty within a continuous period of three years. But the incumbent has passed the prescribed municipal test for the declaration of probation in the cadre of Municipal Secretary Grade III on 18/10/2020 only. Hence the Director has recommended to extend the period of probation of the incumbent in the cadre of Municipal Secretary Grade III up to 18/10/2020 AN and to declare the same with effect from the FN of 19/10/2020.

The Accountant General has informed that the incumbent has not availed any leave other than casual leave during the period of probation. As per the Government Order read 2nd above the appointment of Smt.Vrija N.K, Secretary, Municipal Secretary Grade-III was regularised.

Government have examined the matter in detail and are pleased to extend the period of probation in respect of Smt.Vrija N.K, Secretary, South Paravoor Municipality up to 18/10/2020 as per Rule 21 of General Rules of KS&SSRs, and are also pleased to order that Smt.Vrija N.K, Secretary, South Paravoor Municipality has satisfactorily completed the prescribed period of probation in the cadre of Municipal Secretary Grade-III with effect from 19/10/2020 FN as per Rule 20 (b) of General Rules of KS&SSRs.
