ORDER

As per the Government Order read as 1st paper above Shri.Juhee Maria Tom was appointed as Municipal Secretary Grade-III and he joined duty on 21/03/2017 FN at Thanoor Municipality.

The Director of Urban Affairs has recommended the application of the incumbent for declaring probation vide letter read as 2nd paper above. The Director of Urban Affairs has reported that the work and conduct of the applicant is good and also reported that no disciplinary proceedings/vigilance case is pending against the applicant during the period of probation.

The probation period in the cadre of Municipal Secretary Grade III is two years continuous period of service within a period of three years. The period of probation in respect of Shri.Juhee Maria Tom, Municipal Secretary Grade III is from 21/03/2017 to 20/03/2019. The Principal Accountant General (A&E) reported that Shri.Juhee Maria Tom availed 26 days LWA in the period of probation. But the incumbent has not acquired the prescribed qualification of passing departmental test for declaration of probation until 04/11/2019. Hence his probation in the cadre of Municipal Secretary Grade III is to be extended up to 04/11/2019 AN.

Government have examined the matter in detail and are pleased to declare that the period of probation of Shri.Juhee Maria Tom, Municipal Secretary in the cadre of Municipal Secretary Grade III is extended up to 04/11/2019 AN as per Rule 21 of

General Rules of KS&SSRs, and the probation in the cadre of Municipal Secretary Grade-III is declared as satisfactorily completed with effect from 05/11/2019 as per Rule 20 (b) of General Rules of KS&SSRs.
