ORDER

As per the reference 1st paper above Smt. Anjana James, Assistant Town Planner, Planning Wing, Kerala Local Self Government Department and Shri. Akhil P R, Assistant Director, Directorate of Town & Country Planning, Andhra Pradesh submitted application for inter state mutual transfer.

Smt. Anjana James was recruited through Kerala Public Service Commission vide notification No. 254/2013 dated 31/08/2013 for the post of the Assistant Town Planner (ATP) in the Department of Town and Country Planning, Government of Kerala and appointed in the office of the Chief Town Planner on 07/06/2019. The Chief Town Planner has reported that the period of probation in the cadre of the Assistant Town Planner was declared as satisfactorily completed w.e.f 06/08/2021.

Shri. Akhil. P. R. was recruited through Andhra Pradesh Public Service Commission to the post of the Town Planning Assistant vide notification No.46/2011 dated 29/12/2011 and joined service on 19/03/2014. He was subsequently promoted and posted to the post of Assistant Director, in the office of the Director, Town and Country Planning Department , Government of Andhra Pradesh vide order No.5169/2016/M1-3 dated 28/07/2017 and joined duty on 02/08/2017.

As per the letter read as 2nd above the Chief Town Planner reported that as per Special Rule of Kerala Town & Country Planning Department,

Shri.Akhil.P.R is qualified for the post of the Assistant Town Planner.
