ORDER

As per the G.O. read as 1st paper above, Government have given sanction for the work:-

- Providing new DI pipeline of 600 mm dia Clear Water Pumping Main Puthur to Moothanthara OHSR (Part-1) in Palakkad Municipality - ₹5.44 Crore
- 2. Providing new DI pipeline of 600 mm dia Clear Water Pumping Main Mattumantha to Kalmandapam OHSR (Part-II) in Palakkad Municipality ₹4.56 Crore [Total ₹10.00 Crore]
- 2. The Mission Director, AMRUT as per the letter read as 3rd paper above, informed that the proposal related to the Water Supply works of Palakkad Municipality was placed in the 29th SHPSC for AMRUT.
- 3. The 29th SHPSC for AMRUT decided to revise the AS of the work to ₹10.26 Cr. from ₹10 Cr., due to the increase in road restoration cost and additional cost incurred to Railways. The Additional Amount Rs.0.2593 Cr. shall be met from the savings of the 3 works in WS Sector

subject to the condition that the Council decision in this regard shall be obtained.

Government have examined the matter in detail and are pleased to accord revised Administrative Sanction for the work 1) Providing new DI pipeline of 600 mm dia Clear Water Pumping Main Puthur to Moothanthara OHSR (Part-1) and 2) Providing new DI pipeline of 600 mm dia Clear Water Pumping Main Mattumantha to Kalmandapam OHSR (Part-II) in Water Supply Sector in Palakkad Municipality from 10 Crore to 10.26 Crore, subject to the condition that the additional amount shall be met from the savings of the 3 works in WS Sector and the decision of Palakkad Municipal Council shall be obtained by the Secretary in this regard.
