### ORDER

As per the letter read as 1<sup>st</sup> paper above, an amount of ₹1,46,11,000/- (Rupees One Crore Forty Six Lakh and Eleven Thousand only) has been sanctioned as part of 2<sup>nd</sup> instalment of 1<sup>st</sup> tranche to the State as Central assistance towards conducting Social Audit in the State & Staffing of Independent Social Audit Unit for the financial year 2021-22. The Director (MGNSASK) vide letter read as 2<sup>nd</sup> paper above requested to release the amount urgently in relaxation of the economy orders prevailing. As per the Government order read as 3<sup>rd</sup> paper above authorisation for additional expenditure to the tune of ₹1,46,11,000/- has been granted under the Head of Account 2505-02-101-97-34-Other Charges-3-Other items (Plan -Voted).
