ORDER

As per Government Order read as 3rd paper above, Departmental Tender Committee headed by the Chief Engineer, KSRRDA had been granted delegation of powers to approve tender excess for the PMGSY road works to the subject to the condition that the Chief Engineer shall ensure utilization of Tender savings for road works to the extent possible as per NRRDA guidelines, so that there will not be any additional burden on State. In case of any additional financial burden such cases will be approved with prior Finance concurrence only.

2. The Chief Engineer, KSRRDA, as per the letter read as 4th paper above, pointed out that the above order didn't add any additional delegation than the existing procedure and would delay the awarding of works. In the circumstances, he has requested to modify the aforesaid Government Order, so as to get the delegation of powers to Department Tender Committee headed by the Chief Engineer, KSSRDA to approve and award tender excess for PMGSY road works as dealt with in other

departments.

3.Government have examined the matter in detail. In order to avoid delay in awarding works having tender excess, Government are pleased to grant delegation of powers to approve tender excess for the PMGSY road works to the Departmental Tender Committee headed by the Chief Engineer, KSRRDA subject to the following conditions:

- 1 Total tender excess approved by the Tender Committee during the financial year shall not exceed the budget provision earmarked for the same. Concurrence of Finance Department shall be obtained in case the same exceeds the budget allocation.
- 2. The Chief Engineer, KSRRDA shall ensure that the tender savings for other PMGSY Road works are utilized to the maximum extent possible as per NRRDA guidelines, so that the State burden will be minimum.
