## **ORDER**

As per the letter read as 1st paper above, Government of India had sanctioned, a total amount of ₹10,50,00,00/- (General component - ₹7,35,00,000/-, SCP component - ₹2,10,00,000/- and TSP component - ₹1,05,00,00/-) as 2nd tranche/installment of Central Share for the year 2021-22, for the implementation the projects under Watershed Development Component of Pradhan Mantri Krishi Sinchayee Yojana 2.0 (WDC-PMKSY 2.0).

- 2.Being the implementing agency, the Commissioner for Rural Development (CRD) as per the letter read as 2nd paper above, has requested to release the Central share sanctioned along with the matching state share, which comes to a total amount of \$17,50,00,000/-(Central Share \$10,50,00,000/- and State Share \$7,00,00,000/-), from the current year's Budget allocation to them.
- 3.Government have examined the matter in detail. As per the Budget allocation for WDC-PMKSY for the year 2022-23, the funds available under SCSP and TSP components are insufficient to release the full amount as requested by the CRD. In the circumstances, sanction is accorded to release a total amount of ₹15,00,00,000/- (Rupees Fifteen Crore only) as 2nd tranche/installment of Central Share and

Corresponding State share for the implementation the projects under Watershed Development Component of Pradhan Mantri Krishi Sinchayee Yojana 2.0, from the current year Budget provision as detailed below:
