ORDER

Government of India approved the release of 15th Finance Commission Health Sector Grant (15th FC HSG) for an amount of Rs.427.13 crores for Kerala for 2021-22. Department of Finance vide G.O cited as 1st paper above transferred the above amount to the bank accounts of Director of Panchayats (DP), Director of Urban Affairs (DUA) and Commissioner for Rural Development (CRD).

2. Vide letter cited as 3 rd paper above, Health Department furnished the

local body-wise outlay of 15th FC HSG, as per the matrix finalised by State Mission Director, National Health Mission

- 3. As per the G.O cited as 4th paper above, direction was given to DP, DUA and CRD to release funds to the local bodies as per the matrix finalised by NHM.
- 4. Health Department vide G.O cited as 5th paper above designated State Mission Director, National Health Mission (NHM) as the State Recruiting Agency for recruitment related to 15th FC HSG, and vide G.O cited as 6th paper above designated M/s Kerala Medical Services Corporation dated (KMSCL) as the state agency for effecting all procurement of medicine, medical equipment, diagnostics, consumables, etc related to 15th FC HSG
- 5. Health Department vide letter cited as 7th paper above requested LSGD to transfer funds earmarked for procurement utilising 15th FC HSG to the account of KMSCL; and the funds earmarked for salary to staff (to be recruited as aper the guidelines of 15th FC HSG) to the account of NHM Kerala.
- 6. Government have examined the matter in detail and are pleased to issue the following instructions for the release of funds earmarked in 15th FC HSG.
- i. An exercise of error-free mapping of health institutions with local bodies will be done by the Health Department in consultation with the Local Self-Government Department.
- ii. The detailed fund allocation matrix from the tripartite allocations for DP, DUA and CRD will be prepared by Health Department based on the plans for procurement, recruitment and infrastructure (including civil construction) (utilising 15th FC HSG), and shared with LSGD.
- iii. Bank accounts of KMSCL and NHM will be mapped in PFMS for 15th FC HSG by the PFMS state unit.
- iv. Director of Panchayats, Director of Urban Affairs and Commissioner for Rural Development will thereafter transfer funds

(from the 15th FC HSG for 2021-22 already available with their bank accounts) to the designated bank accounts of KMSCL, NHM and local bodies under their jurisdiction, for the respective activities related to recruitment and infrastructure (including procurement, construction).

- v. The local bodies will place the approved projects to be implemented with 15th FC HSG (2021-22 grant amount) before the District Planning Committees for their information.
- vi. Physical and financial progress of the approved projects will be reported by DP, DUA, CRD, KMSCL and NHM Kerala. Utilisation Certificates will also be prepared and submitted accordingly.
- 7. In respect of 15th Finance Commission Health Sector Grants for 2022-23, LSGD and Health Department shall jointly organise training sessions for local bodies. Planning and resource allocation for the funds for 2022-23 shall be done jointly by LSGD & Health Department with inputs from respective local bodies.
