### ORDER

As per the letter read as 1<sup>st</sup> paper above, an amount of ₹1,46,11,000/- (Rupees One Crore Forty Six Lakh and Eleven Thousand only) has been sanctioned as part of 2<sup>nd</sup> installment of 1<sup>st</sup> tranche to the State as Central assistance towards conducting Social Audit in the State & Staffing of Independent Social Audit Unit for the financial year 2021-22. As per the Government order read as 2<sup>nd</sup> paper above, sanction was accorded to release this amount from the head of account 2505-02-101-97-Social Audit Cell for Mahathma Gandhi National Rural Employment Guarantee Programme-34-other charges-3-other items(PV).

2. As per reference read as 3<sup>rd</sup> paper above, the Director of Social Audit society, requested to renew the release order as the amount could not be encashed from treasury within the financial year.

3. As per the Government order read as 4<sup>th</sup> paper above authorisation

for additional expenditure to the tune of ₹1,46,11,000/- has been granted under the Head of Account 2505-02-101-97-34-Other Charges-3-Other items (Plan -Voted) for utilisation of unspent amount released in the financial year 2021-22, towards social auditing under the Mahathma Gandhi National Rural Employment Guarantee Programme.

In the above circumstances, Government are pleased to re-validate the sanction accorded to release an amount of ₹1,46,11,000/- (Rupees One Crore Forty Six Lakh and Eleven Thousand only) from the head of account 2505-02-101-97-Social Audit Cell for Mahathma Gandhi National Rural Employment Guarantee Programme-34-other charges-3-other items(PV), being the 2<sup>nd</sup> instalment of 1<sup>st</sup> tranche Central Assistance received towards conducting Social Audit in the State & staffing of independent Social Audit Unit for the financial year 2021-22, as per the Government Order read as 2<sup>nd</sup> paper above, to the current financial year.
