ORDER

The Pradhan Mantri Grama Sadak Yojana (PMGSY) is an ongoing scheme and Additional State Share support is provided by the Government of Kerala in addition to State share of the Scheme fund. An amount of ₹20,00,00,000/- is earmarked under the head 4515-00-800-98 in the annual budget 2022-23 as Additional State Share for PMGSY. The major components of the 'Additional State Share' includes i)Fund towards routine maintenance ii)Tender premium over and above estimate cost iii)Expenses for shifting of utilities iv) Maintenance of PMGSY roads which have completed defect liability period of 5 years and v)Rectification of roads damaged due to natural calamities. The fifth component is new one. The Departmental Working Group, per the minutes read above, had approved issue Administrative sanction without specifying the component wise amount, so that flexibility can be allowed for utilizing the funds according to necessity. Hence, t he Member Secretary, KSRRDA, as

per letter read as 2nd paper above, has requested to accord Administrative Sanction for the Budgeted amount of ₹20,00,00,000/- under the H/A 4515-00-800-98 towards the Additional State share for PMGSY Scheme for the year 2022-2023.

2.In the above circumstances, Government are pleased to accord Administrative Sanction for the amount of ₹20,00,00,000/- (Rupees Twenty crore only) as Additional State Share for PMGSY Scheme under the Head of Account 4515-00-800-98 for the financial year 2022-23.
