ORDER

As per the letter read as 1st paper above, Government of India sanctioned Central Share of Rs.3,76,00,000/- towards mobilisation advance for Solid Waste Management (SWM) and Used Water Management (UWM) and an amount of Rs.1,88,00,000/- for Capacity Building under Swachh Bharat Mission(Urban) 2.0 for the FY 2021-22.

As per GO read as 2nd paper above, on receiving the credit memo regarding Central release of Centrally Sponsored Scheme (CSS) and confirmation of Finance (Planning) Department in this regard, in cases where budget provision is available, on receipt of the proposal from Single Nodal Agency, fund release order (Central Share and corresponding State share, if any) for transferring funds shall be issued directly to the corresponding Single Nodal Account designated for the particular CSS.
