### ORDER

An amount of ₹125 crore has been earmarked in the Budget for the current financial year under the Head of account “2217-80-800-76” for implementation of the Ayyankali Urban Employment Guarantee Scheme. It is an ongoing Scheme which intends to address the unemployment and under-employment problems in the urban society. The objective of the Scheme is to enhance livelihood security in urban areas by providing at least 100 days of guaranteed wage employment to every household whose adult members are willing to do unskilled manual labour.

2. As some new components are added in the Scheme, the Director of Urban Affairs, as per the letter read as 2<sup>nd</sup> paper above, submitted proposal for implementation of the Scheme before Working Group Meeting of the Local Self Government Department held on 18.04.2022 and the Working Group considered the proposal and approved it. The component wise financial outlay of the Scheme during 2022-23 is as detailed below:
