## **ORDER**

The Hon'ble KAT vide order dated 16.11.2021 in OA 2093/2021 filed by Shri. Subhagan.A.S, Municipal Secretary Grade I (Rtd) directed the 1st respondent, Secretary, LSGD to pass appropriate orders on Annexure A4 representation filed by Sri.Subhagan for notional promotion.

Shri.Subhagan.A.S,Municipal Secretary Grade I (Rtd) submitted the Annexure A4 representation for notional promotion to the post of the Corporation Secretary/Additional Corporation Secretary from 27.09.2017.

Government have examined the matter by placing the same before the DPC(H) of Urban affairs held on 21.12.2021. The DPC (H) of the Urban affairs Department considered the review petition filed by Shri. Subhagan Municipal Secretary Grade I (Rtd). The applicant was promoted to the cadre of Municipal Secretary Grade I on 06.05.2017.

The DPC(H) held on 27.09.2017 considered the name of three of his seniors in the Select list to the post of the Municipal Secretary grade I and restore their position in the Select List above Shri.Subhagan and promoted them w.e.f 06.05.2017. At that time there were three vacancies in the cadre of Corporation Secretary/Additional Corporation Secretary. After that the DPC (H) held on 04. 01.2018 considered the eligible employees and included above three officers in the Select List in the above vacancies . The disciplinary action initiated against Shri.Subhagan for minor penalty was finalised by exonerating him from all the charges vide G.O.(Rt) No.945/2018/LSGD dated Shri.Subhagan was retired from service on 31.05.2018 . 03.04.2018. His immediate junior Shri. U.S. Satheesan was promoted to the cadre of Corporation Secretary only on 26.10.2019 vide G.O.(Rt)No.2378/2019/LSGD dated 26.10.2019 after the retirement of Sri.Subhagan on 31.05.2018 and none of his juniors were promoted before 31.05.2018. Therefore the Government have rejected the Annexure A4 representation submitted by Shri.Subhagan for notional promotion to the post of ( poor secretary /Additional Corporation Secretary.

The order dated 16.11.2021 in OA 2093/2021 filed by Shri. Subhagan.A.S. is complied with accordingly.
