### ORDER

Government of India had sanctioned an amount of ₹10,50,00,00/-, as per the letter read as 1st paper above, as 2nd tranche/installment of Central Share for the year 2021-22, for the implementation the projects under Watershed Development Component of Pradhan Mantri Krishi Sinchayee Yojana 2.0 (WDC-PMKSY 2.0). Its matching State share was ₹7,00,00,000/-. Out of the total amount of ₹17,50,00,000/-, only ₹15,00,00,000/- could be released, vide Government read as 3rd paper above, due to shortage of funds in the Budget provision under SCP and TSP components. The Commissioner for Rural Development (CRD), as per the letter read as 2nd paper above, has requested for re-appropriation of funds and also for release of full amount.

2.Government have examined the matter in detail. As per Government Order read as 3rd paper above, sufficient fund has been re-appropriated to the respective H/As of SCP and TSP components. In the circumstances, Government are pleased to accord sanction to release the balance amount ₹2,50,00,000/- (Rupees Two Crore and fifty lakh only) of 2nd tranche/installment of Central Share and Corresponding State

share for the implementation the projects under Watershed Development Component of Pradhan Mantri Krishi Sinchayee Yojana 2.0, from the current year Budget provision as detailed below:
