Name of Work: Construction of Footpaths in 4 Locations in

Temple Circle Areas

Current AS Details: Rs.8.57 Cr.

Revised AS Amount Required: Rs:11.57 Cr.

3. The SHPSC has decided to accord sanction to revise the Administrative Sanction of the UT Sector work from Rs.8.57 Cr. to

Rs.11.57 Cr. subject to certain conditions.

Government have examined the matter in detail and are pleased to accord revised Administrative Sanction for the Urban Transport Sector Work of Guruvayur Municipality namely, "Construction of Footpaths in 4 Locations in Temple Circle Areas" from Rs.8.57 Cr. to Rs.11.57 Cr. subject to the conditions stipulated below:
 - a) The additional fund of Rs.3.00 Cr. shall be met from the available savings, if any, in the UT Sector and balance shall be borne by the ULB. In case savings are not available, the entire additional amount shall be borne by the ULB.
 - b) The approval of the Municipal Council shall be obtained.
 - c) The work shall be completed by 31/03/2023.
 - d) Any financial implication due to incompletion of work by 31/03/2023 shall be borne by the ULB.
