ORDER

The Hon'ble Kerala Administrative Tribunal in the order dated 18.11.2019 in OA 761/2018 directed the first respondent to pay interest at the rate of 7% from 01/08/2017 till the date of payment and to release the withheld amount of Rs.1,02,612/-, as the above liability has been set aside by Annexure-A18 order, within three months of receipt of a certified copy of the order.

2. The Director, Urban Affairs in the letter cited has reported that Sri. Premachandran K, was sanctioned Rs. 11,32,958/- from Rs. 12,35,570/- on 17.07.2018 and the with held amount of Rs 1,02,612 on 19.03.2020. As per the Government Order 1st cited direction has been issued to the Director Urban Affairs to disburse the interest for the entire amount from 29.04.2017 (Date on which the disciplinary action was dropped) till the date of disbursal of the part amount (03.07.2017) and thereafter the interest on the withheld amount till that withheld amount was also disbursed till the date of its disbursal. Directions were also issued to

consider the date of authorization of the pensionary amount by the Accountant General while calculating the interest. As per the letter 2nd cited, the Director has sought a clarification on the Government order 1st cited.

3. Government have examined the matter in detail. The applicant Sri. Premachandran K is eligible to get interest for the whole amount from 01.08.2017 to 17.07.2018, and the interest for the withheld amount from 18.07.2018 upto the date of disbursement.

4. In the circumstances, the Director of Urban Affairs is hereby directed to disburse the interest for the whole amount of DCRG from 01.08.2017 to 17.07.2018, and the interest for the withheld amount from 18.07.2018 upto the date of its disbursement.

5. The Government Order read above stands modified to the above extent.
