## **ORDER**

The applicant, Sri. Abu Syed.S, Assistant Engineer has filed OA No.2101/2021 aggrieved by his supersession by the Departmental Promotion Committee, by which his juniors have been promoted to the post of Asst Exe. Engineer, overlooking the seniority of the applicant. The Hon'ble KAT as per its order dtd 12.11.2021 in OA No.2101/2021 has directed the I st respondent, to consider the claim raised by the applicant in Annexure A11 statutory petition preferred by the applicant on merits, by convening an adhoc DPC, if required and pass appropriate orders thereon, in accordance with law, within a period of two months.

2. Sri. Abu Syed . S, was supersseded in the select list of 2021 due to the pendency of disciplinary action for minor penalty in Govt file no. EW1/116/2019/LSGD in connection with the irregularities in Veliam Grama Panchayath, Kollam, which was subsequently finalised as per GO(Rt) No. 2050/2021/LSGD dated 10.10.2021 awarding censure. The Committee which considered his case found that he is eligible for promotion to Assistant Executive Engineer in the vacancy arising after the date of order awarding censure.

3. The Committee considered the case in detail. As there occurred no vacancies in the cadre of Assistant Executive Engineer after the date of awarding punishment during 2021, the Committee decided to uphold the decision of the earlier DPC (H) and not to include him in the select list, 2021 for promotion to the cadre of Assistant Executive Engineer.

The DPC (H) convened on 10.05.2022 when considered the ability and merit of officers to be included in the select list for promotion to the cadre of Assistant Executive Engineer for the year 2022 found that the applicant is eligible for inclusion. Subsequently, he was promoted to the cadre of Asst. Exe. Engineer vide GO read as 3<sup>rd</sup> paper above and the Orders of the Hon'ble Kerala Administrative Tribunal vide 2<sup>nd</sup> paper read above, is compiled with accordingly.
