ORDER

As per the Government Order read as 1st paper above Smt.Seena.H was appointed as Municipal Secretary Grade-III and she joined duty on 17/03/2017 FN. The probation period in the cadre of Municipal Secretary Grade III is two years continuous period of service within a period of three years. The Accountant General (A&E), Thrissur has reported that she has not availed any leave other than casual leave during the probation period. Hence the period of probation in respect of Smt.Seena.H, Secretary, Cherupulassery Municipality is from 17/03/2017 to 16/03/2019. But the incumbent has not acquired the prescribed qualification of passing departmental test for declaration of probation. She passed the test only on 30/09/2021. Hence her probation in the cadre of Municipal Secretary Grade III is to be extended up to 30/09/2021.

The Director of Urban Affairs has recommended the application of the incumbent for declaring probation as per letter read as 3rd paper above. The Director of Urban Affairs has reported that the work and conduct of the applicant is good and also reported that no disciplinary proceedings/ vigilance case is pending against the applicant during the period of probation.

Government have examined the matter in detail and are pleased to extend the period of probation of Smt.Seena.H, Municipal Secretary in the cadre of Municipal Secretary Grade III up to 30/09/2021 AN as per Rule 21 of General Rules of KS&SSRs, and her probation in the cadre of Municipal Secretary Grade-III is declared as satisfactorily completed with effect from

01/10/2021 FN as per Rule 20 (b) of General Rules of KS&SSRs.
