ORDER

As per the letter read as 1st above, two Asst. Engineers namely Smt. Fatima. S and Sri. Afzal. Y of LSGD Engineering Wing were selected for the M Tech Course in Translational Engineering at the Government Engineering College, Barton Hill, Thiruvananthapuram for the academic year 2020-22 as Government sponsored candidates. As per the Proceedings read as paper 2nd above, the Chief Engineer, LSGD relieved the incumbents to join the Course. Later, sanction was accorded to release their Ist semester tuition fee of the course, vide GO read as 3rd paper above. And the sanction was accorded to release their 2nd semester tuition fee of the course, vide GO read as 4th paper above.
