ORDER

The Sri. Santhoshkumar.A, Assistant Executive Engineer has filed OA(EKM) No.813/2022 aggrieved by his supercession in the DPC (Higher) convened on 17.3.2020 and on 10.5.2022, for preparation of select list of eligible Assistant Executive Engineers fit for promotion as Executive Engineer.

2. The DPC convened on 10.5.2022 for preparation of the select list for the year 2022 considered the inclusion of the applicant in the select list 2020 for promotion to the cadre of Exe. Engineer. The applicant was superseded in the above DPC on the grounds of pendency of disciplinary proceedings initiated as per Annexure A13 memo of charges and statement of allegations dated 15.6.2021 in Govt file no.EWA2/32/2021. Later, the disciplinary proceedings pending against the applicant was finalized by absolving from the charges levelled against him vide GO read as 2 nd paper above.

- The Hon'ble KAT in its order dated 22.08.2022 directed the 1 st 3. 2 nd respondents to convene a Review/Adhoc Departmental and Promotion Committee without further delay and at any rate, within a period of six weeks from the date of receipt of a copy of this order and to consider the eligibility of the applicant taking note of the fact that the disciplinary proceedings pending against him, which culminated in his exoneration as per Annexures A11 and A16 orders and his seniority as per Annexure A8 seniority list. On consideration of his eligibility and subject to the decision rendered therein, the applicant shall be considered for inclusion in the select list for the year 2020 and consequential orders issued granting promotion to the post of Executive Engineer with effect from the date of promotion of his immediate junior. The 1 st respondent will ensure that consequential orders are one month from the date of convening of the issued within Departmental Promotion Committee.
- 4. The Review/Adhoc DPC convened on 05.08.2022 included Sri.Santhoshkumar.A, AEE, in the select list of Exe. Engineer 2020 read as 3rd paper above as Sl No.19(a) just below Sri.Asokan.T.M with Rank No. 159(Sl no.19) and just above Smt.Shemi.T.K with Rank No. 162 (Sl No.20). Accordingly the applicant was promoted to the cadre of Exe. Engineer and posted as Exe. Engineer at PMU-KILA as Regional Manager (Tech) on deputation basis vide G.O. read as 4th paper above.

The order of Hon'ble KAT read as 1st paper above is compiled with accordingly.
