## **ORDER**

As per Government Order read as 1st paper above, Government had approved the selection of M/s. Dev Information Technology Private Limited, Ahmedabad as the vendor for the supply, installation and maintenance of the Intelligent Building Plan Management System (IBPMS) to improve Ease of Doing Business in the State. The Director, Urban Affairs was nominated as Nodal officer for all activities in connection with the work.

2.An agreement was signed on 06/12/2017 by Kerala State Industrial Development Corporation Limited (Client), M/s. Dev Information Technology Private Limited (Consultant) and Director of Officer) Urban affairs (Nodal for **Implementation** Intelligence Building Plan Management System. As per the contract, it was envisaged to complete the design and development of software within the first five months and operation & maintenance for the next five years. Thereafter Intelligent Building Plan Management System (IBPMS) was implemented on a pilot basis on 26/05/2018. Since Kerala Municipality Building Construction Rules of 1999 have been replaced by new rules in 2019, the software that was originally prepared has been completely eliminated and new software codes have to be designed.

Moreover, the Kerala Municipality Building Construction Rules 2019 was amended in 2021 and the software was revised again as per this amendment. Hence M/s. Dev Information Technology Private Limited was not able to complete the works within the time limit (five years from 6/12/2017)stipulated in the contract since an amendment to the building regulations could not have been foreseen at the time the contract was drafted.

3.Considering the urgency for implementation of IBPMS as part of Ease of Doing Business ,Building applications upto 300m<sup>2</sup> were accepted through this software only in all municipalities in Kerala from 13/09/2021 onwards. At present the software has been modified so that applications of all categories of buildings can be accepted. As per letter read as 2<sup>nd</sup> above the Director of Urban Affairs proposed that the contract agreement with M/s. Dev Information Technology Private Limited needs to be extended for the next 5 years for smooth operation of the Intelligent Building Plan Management (IBPMS)

Government have examined the matter in detail and are pleased to accord in principal sanction for extension of agreement with M/s. Dev Information Technology Private Limited for a further period two years for the smooth functioning of IBPMS . The Principal Director , LSGD will negotiate the terms of payment in line with the inputs given by Kerala State Industrial Development Corporation Limited on the proposal made by the M/s. Dev Information Technology Private Limited
