ORDER

Government of India vide letter read as 1 st paper above have released an amount of Rs.423,67,01,000/- (Rupees Four hundred and twenty three crore Sixty seven lakh and One thousand only) to the State Government of Kerala being the 1 st installment of 1 st tranche of Central assistance towards Material and Administrative contingency for implementation of MGNREGA for the financial year 2023-24. Out of ₹285,94,74,000/- is this amount, Material component ₹137,72,27,000/- is Administrative component. The Mission Director(MGNREGS) vide letter read as 2 nd paper above, submitted proposal for release of Central Assistance now received along with its corresponding State share.

Government have examined the matter and are pleased to accord sanction to release a total amount of ₹ 518,98,59,000/- (Rupees Five Hundred and Eighteen Crore Ninety Eight Lakh and Fifty Nine Thousand only) being the 1 st installment of 1 st tranche of Central assistance towards Material and Administrative components for

implementation of MGNREGA for the financial year 2023-24 and its matching State share towards Material component, as detailed in the table below:
