ORDER

Ministry of Housing & Urban Affairs (MoHUA) has entered into an Agreement with the Singapore Cooperation Enterprises, an Agency of the Government of Singapore for a Capacity Building training covering water cycle including treatment network management, treatment of used water, recycled water, application of asset management, good O&M practices and application of digital tools in water cycle management.

2) As per the letter read as 1st paper above, MoHUA has informed that four workshops/ capacity building training sessions has been proposed to organize in New Delhi and the training program will conclude with a five day visit to Singapore. The objective of the training is to 'Train the Trainers' who can in turn disseminate the learning to other colleagues in the State Governments and ULBs. The Ministry has requested to Nominate 2 officials from the State for participating in the Four workshops. MoHUA has also informed that the same set of officials will participate in Four workshops and from this core group, 20 officials will be selected for Visiting Singapore and the first workshop is scheduled on 28th & 29th August 2023 in New Delhi

3) As per the letter read as 2nd paper above, the Mission Director AMRUT has requested to accord sanction to him for attending the workshops at New Delhi and visit to Singapore and permit him to avail

'to and fro' air journey. It is reported that the expenditure towards travel and accommodation shall be met from the A&OE funds under the Capacity Building head of AMRUT 2.0.

Alex Varghese IAS, the Mission Director, AMRUT for attending the workshops scheduled to be conducted on 28th & 29th August 2023 and the subsequent 3 workshops at New Delhi.
