- 1) The CSC will provide Clarifications to the Pre-bid queries.
- 2) The CSC will evaluate the Technical Proposals and a Technical Proposal Evaluation Report will be submitted to the SLTC for approval.
- 3) The Committee will prepare the final score of the qualified consultants based on the technical score and financial score and as per the selection criteria envisaged in the RFP.
- 4) The Rank list will be submitted to the State Level Technical Committee (SLTC) of AMRUT for approval and further negotiation process as envisaged in the RFP to finalize the consultant (PDMC)

2.As per the minutes read as 2nd paper above, 6th SHPSC has decided to reconstitute the Consultant Selection Committee (CSC) including the Chief Engineer Projects Kerala Water Authority (KWA)

in the place of Chief Engineer, Sewerage Wing, KWA since the RFP for PDMC selection has been modified with the additional scope of works for the preparation of 24X7 Water Supply Projects, Study for NRW reduction, etc.
