ORDER

As per letters read as 1 to 3 above, the Ministry of Rural Development (MoRD), Government of India has sanctioned a total amount of ₹36,55,44,000/- (General - ₹32,18,61,000/-, SCP - ₹3,77,24,000/- and TSP - ₹59,59,000/-) as the 2nd tranche of 1st instalment of the Central share for the implementation of National Rural Livelihoods Mission (NRLM)/Aajeevika for the year 2023-24 in the State. Being the implementing agency of NRLM in Kerala, the Executive Director, Kudumbashree, as per letter read as 4th paper above, informed that the matching State share of the Central release is ₹24,36,96,000/- (General - ₹21,45,74,000/- SCP - ₹2,51,49,333/- and TSP - ₹39,72,667/-) and thus a total amount of ₹60,92,40,000/- is to be released. As the present balance in the head of account 2501-06-198-48-03 (General component-Central share) is only ₹31,81,39,000/- the Executive Director, Kudumbashree has requested to release the available fund from that head of account and to release a total amount

of ₹60,55,18,000/- as 2^{nd} tranche of the 1^{st} instalment of Central share and its matching State share for the implementation of NRLM for the year 2023-24.

2.Government have examined the matter in detail and are pleased to accord sanction to release a total amount of ₹60,55,18,000/- (Rupees Sixty Crore Fifty Five Lakh and Eighteen Thousand only) to Kudumbashree as 2nd tranche of 1st instalment of the Central share and its matching State Share for the year 2023-2024 for implementation of NRLM in the State, from current year's budget provision as detailed below:
