### ORDER

DPC(H) for the Urban Affairs Department held on 11.11.2020 prepared the Select List for promotion to the post of Municipal Secretary Grade II for the year 2020 published vide Government order read as 1<sup>st</sup> above. Smt.Vrija N K was superseded from the above Select List as neither her probation in the cadre of Municipal Secretary Grade III declared nor her CRs had not been received then.

2. Later her probation was declared as per Government Order read as 2<sup>nd</sup> above wef. 19.10.2020. As per the request read as 4<sup>th</sup> above, she requested to restore her seniority in the cadre of Municipal Secretary Gr II. While submitting the request she was not promoted to the cadre of Municipal Secretary Gr II. As per G.O (Rt) No.478/2023/LSGD

dated 24.02.2023 she has been given regular promotion to the cadre of Municipal Secretary Gr II.

3.The DPC meeting held on 26.10.2023 considered her case and decided to restore her position in the select list for promotion to the post of Municipal Secretary Gr II for the year 2020 published as per G.O.(P)No.82/2020/LSGD dated 18.12.2020, later revised as per G.O. (P)No.13/2023/LSGD dated 03.02.2023, in between Ansal Issac (SL.No.1) and Jesitha P J(SL.No.1A) as Sl No.1A by replacing the Serial No.1A and 1B noted against Smt.Jesitha P J and Shri.Navas A as 1B and 1C respectively and revised select list read as 5<sup>th</sup> above was published accordingly.

4. Smt.Jesitha P.J, immediate junior to Smt.Vrija N K was promoted to the cadre of Municipal Secretary Gr II vide G O (Rt) 184/2021/LSGD dated 22.01.2021.

5. In the circular No.Rules 1/138/2021/P&ARD dated 7.12.2022, it is clarified that if notional promotion is granted to the senior on the grounds of seniority dispute, court order, the same shall be granted with effect from the date of order promoting the junior. As per Rule 23(c)under Part I KSR, the officer shall not be eligible for arrears of salary and allowances in the event of notional promotion.

6. Government have examined the matter in detail and pleased to grant notional promotion to Smt.Vrija N K in the cadre of Municipal Secretary Gr II wef 22.01.2021 ie, the date of order of G.O. (Rt)No.184/2021/LSGD dated 22.01.2021 by which her immediate junior Smt. Jesitha P J promoted to the post of Municipal Secretary Gr II, subject to the condition that she shall not be eligible for arrears of

salary and allowances as per Rule 23(c) under Part I KSRs.
