## <u>ORDER</u>

Shri.Jahamgeer S while serving as Municipal Secretary Gr.I, got admission to the Masters in Public Policy programme of IIT Bombay under Govt. Sponsored category as per G.O (Rt) No.1529/2019/LSGD dated 20.07.2019 after availing Earned leave and Commuted leave. His probation in the cadre of Municipal Secretary Gr.I was declared satisfactorily wef 18.12.2018 vide Government Order read as 1<sup>st</sup> above.

2. The DPC (Higher) held on 02.09.2019, prepared and published the select list for promotion to the post of Corporation Secretary/Additional

Corporation Secretary as per the Government order read as 2<sup>nd</sup> above. Shri.Jahamgeer was not considered for promotion to the post of Corporation/Additional Corporation Secretary for the reason that he was on leave wef. 21.07.2019 to 20.07.2020 for completing the in campus Masters in Public Policy course conducted by IIT Mumbai. Shri. Jahamgeer S was promoted to the cadre of Corporation Secretary vide G.O (Rt) No.184/2021/LSGD dated 22.01.2021.The Director of Urban

Affairs had forwarded his request read as 4<sup>th</sup> above, for restoring his seniority in the cadre of Corporation Secretary/Additional Corporation Secretary wef the date of promotion of his immediate junior Sri. Naisam.

3. As per Rule 8 (b) Part II KS&SSR and Circular No.72/2005/Fin dated 30/12/2005 an employee on leave other than KSR Part I Appendix XII A, Appendix XII B and Appendix XII C can be considered for promotion. Also, in serial No.3 in the Appendix to the above circular, it is clarified that leave without Allowance availed under Rule 88 Part I KSRs shall be considered for promotion, seniority and calculation of half pay period.

4.The Departmental Promotion Committee held on 26.10.2023 considered his case and have decided to include Shri Jahamgeer S in the Select List for promotion to the post of Corporation Secretary/Additional Corporation Secretary for the year 2019 published as per G.O (P) No.71/2019/LSGD dated 18.10.2019 in between Smt.Bini K.U (Serial No.2) and Sri.Naisam A.S (Sl.No.3) as Serial No.2A, accordingly the revised select list was published vide G O (P)No.58/2023/LSGD dated 06.11.2023.

5. His immediate junior Sri. Naisam A.S was promoted to the cadre of Corporation Secretary/Additional Corporation Secretary as per G O (Rt) No.2378/2019/LSGD dated 26.10.2019.

6. In the circular No. Rules 1/138/2021/P&ARD dated 7.12.2022, it is clarified that if notional promotion is granted to the senior on the grounds of seniority dispute, court order, the same shall be granted with effect from the date of order promoting the junior. As per Rule 23(c)under Part I KSR, the officer shall not be eligible for arrears of salary and allowances in the event of notional promotion.

7. Government have examined the matter in detail and pleased to grant notional promotion to Shri. Jahamgeer S in the cadre o f Corporation Secretary/Additional Corporation Secretary wef 26.10.2019 ie, the date of order of G.O (Rt) No.2378/2019/LSGD dated 26.10.2019 by which his immediate junior Shri.Naisam A S promoted to the post of Corporation Secretary/Additional Corporation Secretary, subject to the condition that he shall not be eligible for arrears of salary and allowances as per Rule 23 (c) under Part I KSRs.
