### ORDER

Government have accorded sanction for constructing LIFE apartments, consisting of two blocks, in 70 cents of land owned by Greater Cochin Development Authority (GCDA) at west Rameshwaram, Fort Kochi for the rehabilitation of 82 families of P&T colony under LIFE Mission project. The administrative sanction for an amount of Rs.14,61,69,100,for the project was issued as per the order read as 1<sup>st</sup> paper above.

2. Agreement has been executed between GCDA and LIFE Mission, on the condition that an amount of Rs. 903 lakh shall be given to GCDA for this work by LIFE Mission and the amount shall be released in five instalments according to the progress of the work. The

first, second and third instalments were released to GCDA ,each amounting to Rs.200 lakh as per the orders read as second ,third and fourth paper above respectively.

3. The Chief Executive Officer LIFE Mission as per the letter read as 5<sup>th</sup> paper above, has requested to release an amount of 200 lakhs from Budget Head 4217-60-051-95 (P) of LIFE Mission to the Secretary, GCDA as fourth instalment.

Government have examined the matter in detail and are pleased to release an amount of Rs 200 lakh ( Rupees Two Hundred Lakh Only) from Budget Head 4217-60-051-95 (P) of LIFE Mission to the Secretary, GCDA, Cochin and credited to PSTSB A/c No.799012700001785 at Additional Sub Treasury, Ernakulam as fourth instalment towards the construction of LIFE Apartments at West Rameshwaram, Fort Kochi in Ernakulam district.
