## <u>ORDER</u>

The 34<sup>th</sup> SHPSC has considered the proposal for new Water Supply Sector Work, "WET Upgradation" of Thrissur Municipal Corporation under AMRUT 1.0. Based on the recommendation of 29<sup>th</sup> SLTC of AMRUT as per the minutes read as 1<sup>st</sup> paper above, State Level High Powered Steering Committee (SHPSC) of AMRUT-1.0 has decided to accord Administrative Sanction for the new Water Supply sector work, "WET Upgradation", for an amount of Rs.8.58 Cr., subject to the following condition

- The amount required (Rs.8.58 Cr.) shall be met from the savings in the work, "Design, construction & commissioning of the 3 MLD WTP, reservoir and pumping main for Ollukkara Zone"
- Any financial implication due to non-completion of the work by Mar-2024 shall be borne by the ULB
- Approval of the Council shall be obtained.

2. As per the letter read as 2<sup>nd</sup> paper above, Mission Director, AMRUT has requested to accord Administrative Sanction for the new Water Supply Sector work, "WET Upgradation" of Thrissur Municipal

Corporation based on the decision of 34<sup>th</sup> SHPSC.
