### ORDER

34<sup>th</sup> State Level High Powered Steering Committee (SHPSC) of AMRUT-1.0 has considered the proposal of Kochi Municipal Corporation for approval of Administrative Sanction for 6 new works under Water Supply Sector of AMRUT 1.0 as detailed below

- 1) Interconnection of existing 1100 mm MS with 800 mm DI at Thevara - Rs.0.60 Cr.
- 2) Supply and fixing valves of various sizes at Maradu WTP - Rs.0.30 Cr.
- 3) Pressure grouting to arrest leakage of clarifier at the WTP and allied works- Rs.0.50 Cr.
- 4) Construction of drain and flooring work at tanker filling point- Rs.0.65 Cr.
- 5) Fixing of new pump sets and laying of additional pumping line from WTP to tanker filling point and allied works – Rs.0.55 Cr.
- 6) Supplying and fixing 25 Tonne EOT crane at Pazhoor RWPH - Rs.0.40 Cr.

2. Based on the recommendation of 29<sup>th</sup> State Level Technical Committee (SLTC) of AMRUT, as per the minutes read as 1<sup>st</sup> paper above, 34<sup>th</sup> SHPSC has approved the issuance of Administrative Sanction for 6 new Water Supply sector works for an amount of Rs.3.00 Cr., subject to the following conditions:

- The amount required (Rs.3.00 Cr.) shall be met from the savings available (Rs.7.257 Cr.) in the completed works of the ULB in the WS, SWD, UT and PRK sectors

- Any financial implication due to non-completion of the work by Mar-2024 shall be borne by the ULB
- Approval of the Council shall be obtained.

3. As per the letter read as 2<sup>nd</sup> paper above Mission Director, AMRUT has requested to accord sanction for 6 new works under Water Supply sector of AMRUT 1.0 in Kochi Municipal Corporation, based on the decision of 34<sup>th</sup> SHPSC of AMRUT

4. Government have examined the matter and are pleased to accord Administrative Sanction for an amount of Rs.3.00 Cr. for above mentioned 6 new works under Water Supply sector of AMRUT 1.0 in Kochi Municipal Corporation, subject to the following conditions

- The amount required (Rs.3.00 Cr.) shall be met from the savings available (Rs.7.257 Cr.) in the completed works of the ULB in the WS, SWD, UT and PRK sectors
- Any financial implication due to non-completion of the work by March-2024 shall be borne by the ULB
- Approval of the Council shall be obtained.
