ORDER

The 34th State Level High Powered Steering Committee (SHPSC) of AMRUT-1.0 has considered the proposal of Alappuzha Municipality for approval of Administrative Sanction for 1 UT sector work, 1 SEW sector work and 4 SWD sector works under AMRUT 1.0 as detailed below.

I) Urban Transport (UT) Sector:

Pedestrian Lane development in Punnamada Ward – Rs.0.115 Cr.

II) Sewerage (SEW) Sector:

Ultra Filtration Unit & Online Monitoring System – Rs.0.385 Cr.

III) Storm Water Drainage (SWD) Sector:

- 1) Side Protection of Thottunkal thodu in Zacharia Bazar ward and Thode leading to Shadamani thodu in Municipal Stadium ward – Rs.0.20 Cr.
- 2) Side protection work in Puthuval opposite to Che Guevara boat jetty and Kochuparambil thodu opposite to Punnamoottil Boat jetty in Nehru Trophy Ward – Rs.0.30 Cr.
- 3) Side protection works of Mangalam thodu in Karalakam ward, Karalasserry thodu near bypass in Arattuvazhi ward, Karyampallyil RCC drain near Mattancherry Bridge in Power House ward, thodu between Vallikad to Velliparambu thodu in Kalath ward – Rs.0.40

4) Side protection works of Panachithara thodu in Pallathuruthy ward – Rs.0.20 Cr.

2. Based on the recommendation of 29th State Level Technical Committee (SLTC) of AMRUT, as per the minutes read as 1st paper above, 34th SHPSC of AMRUT has decided to accord Administrative Sanction for 6 new works (UT – 1 no. – Rs.0.115 Cr., SEW – 1 no. – Rs.0.385 Cr. & SWD – 4 nos. – Rs.1.100 Cr., Total – Rs.1.600 Cr.), subject to the following conditions:

- The total amount required (Rs.1.600 Cr.) shall be met from the savings available (Rs.1.600 Cr.) in the completed works of the ULB
- Any financial implication due to non-completion of the work by Mar-2024 shall be borne by the ULB.

3. As per the letter read as 2nd paper above, Mission Director, AMRUT has requested to accord Administrative Sanction for 6 new works under AMRUT 1.0 in Alappuzha Municipality, based on the decision of 34th SHPSC

4. Government have examined the matter and are pleased to accord Administrative Sanction for an amount of **Rs.1.600 Cr. for 6 new works** (1 work under Urban Transport Sector – Rs.0.115 Cr., 1 work under Sewerage Sector – Rs.0.385 Cr. & 4 works under Storm Water Drainage Sector – Rs.1.100 Cr.,) under AMRUT 1.0 in Alappuzha Municipality as detailed above, subject to the following conditions:

- The total amount required (Rs.1.600 Cr.) shall be met from the savings available (Rs.1.600 Cr.) in the completed works of the ULB
- Any financial implication due to non-completion of the work by March-2024 shall be borne by the ULB.
