ORDER

As per the G.O. read 1st above the third stage of assessment in the DCAT is the technical assessment by an expert group. The technical assessment of the Local Self Government Institutions shall be conducted at the cluster level which are formed during the DCAT peer assessment process. The Technical Assessment Expert Group will be responsible for finalizing the DCAT evaluation scores of the LSGIs. DCAT District Coordinator shall be responsible for the overall coordination of the Technical Assessment.

The objective of the technical assessment

1. Assessing the authenticity, consistency, relevance, and limitations of the annual plan projects and governance considered in the DCAT assessment initiatives related to climate change, disaster management and resilience building of the concerned LSGI.
2. Review the scores of self-assessment by the LSGIs and suggest changes as required with justification in the technical assessment report

Role of the Technical Assessment Expert Group

1. Shall consult with the LSGIs, inspect the project documents and visit the project areas as part of the technical assessment as needed.

2. Shall ensure that none of the projects in the relevant areas of climate and disaster management is omitted from the DCAT assessment.
3. Shall ensure that only those projects that are approved by the DPC have been considered for the DCAT assessment.
4. Projects that are irrelevant based on the DCAT queries shall be removed and the score shall be recalculated by the Technical Assessment Expert Group as needed.
5. The working group on disaster management, climate change, environmental protection, and biodiversity management shall provide necessary assistance for the technical assessment as required.
6. The technical assessment shall be completed within 15 days after the constitution of the Technical Assessment Expert Group by the Joint Director, LSGD.
7. The technical assessment report shall be submitted to the KILA core group and Joint Director, LSGD of the concerned districts.

Revised Structure of Technical Assessment Expert Group

The structure of the Technical Assessment expert group is as follows,

1. Block panchayat level implementation officers (2 for each cluster)
2. DCAT District Coordinator / Disaster Management District Coordinator
3. DCAT block coordinator
4. One Representative from KILA / KILA resource person as decided by the People's Plan campaign district facilitator (convenor)

For each cluster, one Technical Assessment Expert Group shall be constituted by the Joint Director, LSGD.

The Block level implementation officers shall be nominated by the Joint Director, LSGD.

Joint Director, LSGD shall also nominate one of the block panchayat level implementation officers from the Technical Assessment Expert Group as the chairperson of the Technical Group.
