### ORDER

Sri. K. Muhammed Haji, contractor, PWD was awarded the work of PMGSY-2008-2009, PHASE VII, Package No.KR 04-21 Kalluvalappu Pathikkal road, Kuthuparamba Block in Kannur. After executing the agreement, the Contractor requested for the revision of schedule of rates to DSoR 2016. But the Chief Engineer, KSRRDA rejected the request. Against the order of the Chief Engineer, the Contractor filed a petition, read as 1st paper above, before the Standing Empowered Committee. The Chief Engineer as per letter read as 2nd paper above has reported that the Contractor selected Sri. R. Murukeshan, Chief Engineer (Rtd.), PWD as the Non-official Member for the Standing Empowered Committee.
