ORDER

As per the letter read as 1st paper above, the Ministry of Rural Development (MoRD), GoI had sanctioned a total amount of ₹119.7425 crore towards the 1st Tranche of 1st instalment of Programme fund under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the Financial Year 2024-25. Accordingly the Member Secretary, KSRRDA (implementing agency of PMGSY in Kerala), as per the letter read as 2nd paper above,has requested to release a total amount of ₹202.2425 crore, including the State Share of ₹82.50 crore, from the current year's Budget allocation.

2.Government have examined the matter in detail and are pleased to accord sanction to release a total amount of ₹202,24,25,000/-(Rupees Two hundred and two crore Twenty four lakh and Twenty five thousand only) as the 1st tranche of 1st instalment of Programme Fund under PMGSY for the year 2024-25, from the current year's Budget provision, as detailed below;
