### ORDER

The Hon'ble Supreme Court appointed Justice (Rtd.) Siri Jagan Committee to decide on the compensation to be awarded to the victims of stray dog menace in Kerala. The Hon'ble Supreme Court in its Judgment dated 16.07.2018 in CC No. 944/17 in WP (C) No. 599/2015 read as 1<sup>st</sup> paper above ordered that it would be the obligation of the State to see that the compensation for stray dog victims as recommended by the Justice (Rtd.) Siri Jagan Committee is strictly complied with and if it is not complied with the competent authorities of the State shall be liable for contempt of the Supreme Court and be adequately punished. As per letter read as 2<sup>nd</sup> paper above, Justice (Rtd.) Siri Jagan Committee has furnished 42<sup>nd</sup> report which recommended the payment of compensation to the victims with interest @ 9% from the date of claim till payment.

Government have examined the matter in detail and are pleased to accord sanction to the Secretaries of the local bodies concerned to pay the compensation awarded by the Committee to the following claimants in the 42<sup>nd</sup> report of the Justice (Rtd.) Siri Jagan Committee with interest @ 9% per annum from the date of claim till payment.
