ORDER

As per the G.O. read 1 st above, the Government have granted permission for availing assistance from the German Bank, KfW for a loan of EURO 100 million and a grant of EURO 2 million for Accompanying Measures (AM) as Climate Loan Kerala under Kerala Climate Resilience Programme under RKDP. Government of Kerala entered into a Separate Agreement (SA) with the KfW under the programme. Local Self Government Department is the nodal Department for Urban development and planning sector of AM grants. Government, as per the G.O. read as paper 2nd above, have approved the Standard Operating Procedures (SOP) that outlines the roles, processes and procedures for utilization, implementation, and administration of the Accompanying Measures grant of Euro 2 million under the Climate Loan Kerala Programme. As per the SOP, the Rebuild Kerala Initiative (RKI) Secretariat is in charge of the

overall management and implementation of the AM Grant including procurement.

Accordingly, vide G.O read as 3 rd paper above, Government authorized the Chief Executive Officer, RKI to conduct the procurement of the services for 'Consultancy Services for Capacity Development for Risk-informed and Effective Urban Planning and Policy Formulation' and vide GO read as 4th paper above, 'M/s.CRISIL Risk and Infrastructure Solutions, India (now CRISIL Limited) in association with Thomas Stellmach Planning &Architecture (TPSA), Germany and Great India Tourism Planners & Consultants (GITPAC)' was selected for the Consultancy Services
- (3). Roles and Responsibilities of Nodal Departments of KfW AM grant are prescribed in the Clause number 2.2.5 of SOP as per which Nodal departments are entrusted with the responsibility of approval of all the deliverables of the consultancies. Various deliverables will be provided and these deliverables are proposed to be vetted and comments if any has to be provided within the timelines stipulated in the RFP document. A committee was constituted vide G.O read as 5th paper above, to evaluate the reports submitted.
