Hence it is requested to additionally authorize an amount of Rs.20,00,00,000/- (Twenty crores only) under the H/A. "2015-00-109-99-00-34-3" as the advance for the purchase of Electronic Voting Machines and DMM in connection with the upcoming General Election to Local Self Government Institutions.
