**ORDER**

The Jal Hi Amrit (JHA) initiative under AMRUT 2.0 aims to incentivize urban local bodies (ULBs) to improve the quality of treated used water by ensuring efficient operations of Used Water Treatment Plants (UWTPs) and promote recycling and reuse. As per the guidelines for the scheme, the Ministry of Housing and Urban Affairs (MoHUA) will provide financial incentives to eligible ULBs to improve the quality of used water treatment. The incentives will be disbursed through the State Nodal Agency (SNA) of the A&OE component of AMRUT 2.0. The funds will be deposited into an escrow account dedicated to UWTP improvement to the concerned ULBs and must be utilized for specific activities to improve the efficiency and sustainability of UWTPs. Incentive will be released to the State in 70:30 incentive structure, based on the achieved Clean Water Credits of 3-stars and above. Setting up the Water Resource Recovery Cell (WRRC) to promote sustainable and circular management of used water and bio solids at the state level is a prerequisite for releasing the first 70% incentive. The total amount of fund allocated for incentive under JHA for the UWTP/ STPS in the State of Kerala is Rs. 7.50 Cr

2. As per the letter read as 1<sup>st</sup> paper above, MoHUA has conveyed Mother Sanction for an amount of Rs.5,25,00,000/-(Rupees Five Crore Twenty-Five Lakh only) as 1<sup>st</sup> installment of incentive (i.e.70% of the total amount) for 15 STPs under Jal Hi Amrit initiative under AMRUT 2.0 through SNA SPARSH. Details of STPs is appended as annexure to this G.O

3. As per the letter read as 2<sup>nd</sup> paper above, the Mission Director, AMRUT has requested to take necessary action for additional authorization to receive central

assistance and release of the funds under following Budget Heads to receive Central Government Assistance (DDO CODE: O1O467DO53), as detailed below;

As perv G.O read as 3<sup>rd</sup> paper above, Government have authorized additional expenditure to the tune of Rs.52500000/- (Rupees Five Crore Twenty Five Lakh Only) under respective head(s) of account, for the release of Central assistance sanctioned towards first installment of incentive under Jal Hi Amrit a component of AMRUT 2.0.

6. Government have examined the matter in detail and are pleased to accord sanction for the release of an amount of **Rs.5,25,00,000/-(Rupees Five Crore Twenty-Five Lakh only)** from the respective Budget Heads, towards the 1<sup>st</sup> installment of incentive for 15 STPs under Jal Hi Amrit initiative, AMRUT 2.0 through SNA SPARSH and allocate the amount to the Mission Director AMRUT (**DDO CODE: 010467D053**), as detailed below. Sanction is also accorded for the transfer credit of the amount to the Escrow Account of AMRUT 2.0 maintained by the MISSION DIRECTOR AMRUT 2.0 JHA KERALA with Account Number **7996326654** in Indian Bank, Thycaud Branch (**IFS Code: IDIB000T021**).
