ORDER

Government of India launched AMRUT 2.0 for 93 Urban Local Bodies in Kerala, in succession to AMRUT 1.0. As per G.O read as 2 nd paper above, sanction has been accorded for the continuation of State Mission Management Unit (SMMU) and City Management Units (CMMUs) for AMRUT 2.O. Government have also approved proposed Staff Structure and Remuneration of the State Mission Management Unit and City Management Units

- 2. Based on the proposal submitted by the Mission Director, AMRUT, upon appraisal made by the performance appraisal committee, as per G.O read as 3rd paper above, Government have accorded sanction to the Mission Director for extending the service of experts in SMMU and CMMU and service of supporting staff with effect from 01.04.2023, subject to the condition that Mission Director shall continuously evaluate performance of the experts who scored marks below 60% in the appraisal made by appraisal committee and their service shall be terminated if the performance is not improved.
- 3. As per proceedings read as 4th paper above, the Mission Director, AMRUT has accorded sanction for the continuation of services of contract staff and daily wage staff engaged in the AMRUT projects from 01.04.2024 to 31.03.2025.
- 4. As per G.O read as 1st paper above, appointment on contract basis shall be made only with the prior approval of the Government. Such contract appointment

shall be limited to a period of one year only and may be extended for one more year at the discretion of the Head of the Department. After a period of two years, the contract shall be renewed only with the approval of Government.

- 5. As per the letter read as 5th paper above, the Mission Director has recommended the retention of officials/experts and daily wage staff to ensure the seamless continuation and successful completion of the AMRUT Mission and requested for the extension of the tenure of all staff under CMMUs and SMMUs for a further period of one year, i.e., up to 31.03.2026
- 6. Government have examined the matter in detail and pleased to extend service of following contract staffs and daily wage staff (within the age limit of 60 years), appointed in the State Mission Management Unit (SMMU) and City Mission Management Units (CMMU) under AMRUT 2.0 for a period from 02.04.2025 to 31.03.2026, subject to the following conditions;
 - i. The staff strength as approved in G.O read as 2nd paper above shall be strictly adhered to.
 - ii. For daily wage employees and contract staff, the conditions stipulated in G.O read as 6th paper above shall be followed.
 - iii. All contract and daily wage employees shall furnish an undertaking to the effect that they shall not claim permanency in the Mission, Department, or Government.
