ORDER

As per the Order read as 1st paper above, Government constituted a Task Force Committee as part of State Business Reform Action Plan 2024 and assigned its duties and responsibilities. As per the letter read 2nd above, Principal Director has informed that at present, the registration and licensing of third parties for undertaking building-related inspections is carried out by the District Joint Directors of the Local Self Government Department and in order to ensure accountability, transparency and quality in the functioning of such third- party licensees, it is essential to put in place a mechanism for monitoring and oversight of the certification system of these licensees. In this context, Principal Director has requested that the duties and responsibilities of the Task Force Committee constituted vide Govt order above shall be modified by adding the following additional duty.

"Monitor and provide oversight of the certification system of the licensees who are assigned with the third-party inspections, to ensure accountability, uniformity and quality of compliance."

Government have examined the matter and are pleased to include the additional duty mentioned above as follows.
