### ORDER

The Ministry of Rural Development (MoRD), GoI, vide letter read as 2nd paper above, had convey the issue of Mother Sanction of a total amount of ₹96,20,30,000/- (General-₹84,70,68,000/-, SCP-₹9,92,81,000/- and TSP- ₹1,56,81,000 /-) towards 2nd tranche of 1st installment of Central share under SNA SPARSH for the year 2025-26 for the implementation of NRLM in the State. The Central and State share proportion is in the ratio of 60:40. Being the implementation agency of NRLM in the State, the Executive Director, Kudumbashree, as per the letter read as 3rd paper above, has informed that the total amount including matching State share comes to ₹160,33,83,333/- and the current balance under State Head for NRLM for the year 2025-26 is only ₹63,96,62,114/-. The same is insufficient to release the entire amount. Therefore, the Executive Director has requested to release the available amount in the State Head at the earliest.

2. Government have examined the matter and are pleased to accord sanction to release the available amount in the State share H/A for NRLM ₹63,96,62,114/- (Rupees Sixty three crore Ninety six lakh Sixty two thousand One hundred and fourteen only) towards the aforesaid Mother Sanction of Central share and corresponding State share for the

year 2025-26 for the implementation NRLM in the State from the current year's budget provision, as shown in the table below, subject to the conditions stipulated in the Circular read as 1st paper above.
